2. How could our city be improved? Please provide your top 2-3 ideas.	We need to get back to the basics with government, focusing on streets, traffic and parking, emergency services (Police and Fire) and city services such as water and sewer. We should not be approving any more zone requests to increase density until our streets can handle the traffic. Our Urban Renewal Agency should be an elected board who answers to the people of Coeur d'Alene.	Addressing long term solutions for affordable, attainable, and available housing for people who need to live in the town they work. Addressing traffic issues and better communication from city to/from citizens.
3. What are your views on the rapid growth of North Idaho? How should the city council manage growth?	I would like to see our city slow the pace of growth. Growth can be managed through limiting zone changes while protecting property rights. Council could also increase impact fees so growth can pay more of the burden it is causing on the local citizens. We should look at developers to carry some of the cost of improving intersections, that are already failing, if they want to increase density.
