Some students are troubled and can not learn easily. Frequently problems come to school from home: divorce, substance abuse, inadequate sleep, poor nutrition, poverty, and violence. Counselors are trained professionals who often diagnose problems parents many do not see. It is their responsibility to work with and respect parents in addressing the stresses that comes from home and find a solution. At LPOSD there has been a significant increase in counseling demand during to the pandemic. Families are under stress because of finances and health. Elementary age children are being counseled to deal with depression, anxiety, and schizophrenia.
