If we are unable to do this, then a constitutional amendment to hold assessments, or taxes, at the level when the property was purchased would be helpful as well. A minor improvement would be a rolling average assessment to reduce the volatility of property values.	At minimum, I would like to see a 'Proposition 13' type system that will require a constitutional amendment. At best, I would be in favor of a property tax repeal.
12. In your opinion, should the House of Representatives and the Senate have their own attorney/legal representation apart from the Attorney General?	The Legislature should have their own legal representation separate from the attorney general. This is an effort we have tried to get accomplished for a few years, and, last year, separate counsel was provided to the legislative services office with the intent of serving legislative needs.
