1. What is your name, what office are you running for and why are you running for this position?	My name is Jordan Redman. I am running for Legislative Representative for District 3, Seat B. I am running for this office because I feel that I am being called by God to step into this arena. I feel it is important to have people involved in government that have experience owning local businesses, own land locally, and are raising their family locally. For example, I fully support the ownership and use of firearms, but passionately oppose their use to murder others.</p>
