5. Our county is growing very rapidly, where do you see we need to improve infrastructure and what are your plans to improve it?	Shoshone County needs a strong Planning department, staffed with a knowledgeable professional to provide guidance as we face unprecedented growth that is competing for the remaining flat ground in the county now. We need proactive responses to the huge number of visitors our county experiences annually, in particular in the summer months. Our road and solid waste infrastructure are not keeping up with the demand. I plan to focus my energies on problem solving, perhaps with the help of a citizens' committee, for the purpose of developing 1,2 and 5 year plans immediately, and then coming up with 10 and 20 year plans to channel and manage growth in a way that is positive for all - residents here now and those to come.	Taxes pay for our roads to be repaired, but funds get diverted and projects get put off. We pay gas taxes at the pump, and trucks pay road use taxes; there is also federal and state money given to provide for roads and maintenance. Our roads, because we live in a mountainous region where they are exposed to extreme weather conditions, are really needing improvement. There is more traffic and population is increasing. We really only have one viable option of transportation in the Silver Valley. We need more accountability of what is done with road taxes and money already acquired for repair and replacement projects. We have a short time period of time in which roads can be repaired. Summer is the only time these projects can really be accomplished. We have unique challenges, and speaking with the highway and county departments to see what they think should be done would be a good start. I do not support legalization of this gateway drug. In my own research, I have seen where the human cost in quality of life, increasingly serious drug use encouraged, and increase in the number of drug-related accidents and incidents do not make this a profitable move. I have been approached by supporters of this idea who believe the increase in tax revenues makes it worth it. It does not in my opinion.	I do not support legalizing marijuana. I realize there are medical uses, but then it should be treated as a medical product. Usually the use of marijuana creates the need for more potent drugs. In states that have made it legal, there are not enough protections for the public, such as in those who are Driving while Under the Influence, or people smoking at Public Events-causing others to inhale it. Truck Drivers and other people in other professions still have to have random drug tests, and being around heavy concentrations of marijuana smoke can cause them to fail their drug test and their ability to drive and work. Marijuana affects people differently and can cause some to be aggressive. It can be abused and is a real problem with young people. Young brains are still devoloping in adolescence. THC, the main active chemical in marijuana, strongly alters the way sensory information is processed by the brain: learning, memory, attention span and perceptin are all inhibited with recurrent marijuana use.
