1. What is your name and what office are you running for?	Declined to Respond	Diana Sheridan, North Idaho College Zone 2. (All Kootenai County voters get to vote for me)
2. How could North Idaho College be improved? Please provide your top 2-3 ideas.	Declined to Respond	 a. Thorough transparency in all contracts. Fort Myer property was purchased without providing Trustees the 90+ page detailed appraisal prior to the purchase. They did 1 appraisal and should have had 2-3 appraisals for a million-dollar property. b. All contractual agreements are upholding the best interest of NIC. c. I will work with all Board members so that the continuance of NIC's full accreditation will be assured. d. Having the Board support Workforce Training Programs. I would like to expand the Parker Technical Center that attracts businesses to this area. e. Ensure education not indoctrination. All candidates for North Idaho College claim conservative values, but my opponent has been recorded saying he would be open to reinstituting the mask mandate on campus and I would strongly oppose any medical mandates. Students need clear policies and NIC's policies are riddled with vagueness.

Educational freedom for students as well as instructors must be valued. Return the emphasis of teaching back to how to think not what to think. I want a place for students to learn how to write and how to create skillset development, not receive ideological indoctrination. b. NIC should advance students and develop individuals who contribute to society, the local economy, and the Idaho workforce needs. c. 5. If faced with a budget deficit, would you support cutting spending or increasing student fees or tuition? What would be your reasons for this decision?	Declined to Respond	 a. I would support cutting spending and reprioritize certain allocations in the budget. Staff personnel have steadily increased while student enrollment has significantly declined over that same period of time. This needs to be reviewed and I have solutions to propose. b. Tuition is already maxed out to the maximum value allowed by legislature. Idaho's 4-year universities just call other student costs "fees" instead of tuition to expand beyond the maximum value allowed by Idaho's legislature. I think that is wrong. c. Parker's Carpentry program was shut down due to being unable to hire instructors at the low pay rates instructors offered. The president is making 330k with total package. I would re-focus the budget on the workforce to better meet the needs of students. d. For example, the golf coach is practically a full-time volunteer and making 19k per year and coaching both men's and women's golf teams. I would ensure our sports teams receive the administration support required for the students to succeed.

12. What does the term "education" mean to you?	Declined to Respond	Education is how to think not what to think. Students should not be forced to swallow an instructor's ideology to pass courses, that's indoctrination.
13. Do you support or oppose the legalization of marijuana? Why or why not?	Declined to Respond	a. I would be in-favor of legalizing it for prescribed medical purposes.b. Overall, I have concerns of legalizing broad general consumption.
14. What is your background and why does it qualify you for this position?	Declined to Respond	 a. I believe you need business professionals on the Board of Trustees. I am a business Executive Officer for 38 years and decades as President/Vice President. I know how to set expectations and hold people to it. b. Innovation in Education needs to happen and it is hard for government to innovate on its own. A Board of Trustees, coming from and elected by the community, holds NIC to the community's expectations. c. I have 25 years of student and family advocacy specifically in education and I did my initial training through Parents Are Vital in Education (P.A.V.E.) I started as a volunteer pro-bono advocate and eventually became a paid advocate. I came out of retirement to solve the problems I see and heard directly from students. The Board of Trustees needs to work together, respect duly elected trustees, and welcome all viewpoints on campus.

1. What is your name and what office are you running for?	Declined to Respond	My name is Mike Waggoner and I am running for NIC Zone 5 Trustee. To clear up a common point of misunderstanding; all residents of Kootenai County can vote for me.
2. How could North Idaho College be improved? Please provide your top 2-3 ideas.	Declined to Respond	First, is transparency, as it stands, a large portion of our community believes NIC is anti-Christian. In order to change this belief, thorough investigations must be done and those investigations must be open to the public, at least to some degree. Secondly, I am concerned about the cutbacks in technical programs. I intend to look into why the programs had the problems that caused them to be cutback. After doing so, I would like to reintroduce these programs as it is important for our community to have local workers for technical jobs that we didn't import from somewhere else.
3. What is your educational philosophy and how do you plan to implement this philosophy as a member of the board of trustees?	Declined to Respond	I am of the view that academic freedom should be one of the core principles driving education. I am concerned that NIC has several programs that do not care for academic freedom and like to use it as a shield in order to indoctrinate students. I have heard stories of students being required to write on subject matters that they did not want to write on and that bore no relation to the class they were taking. They were apparently told they would have to write on the subject or their grade would be at risk. Academic freedom is not only for the faculty and it is certainly not coercing a student into parroting claims that they morally disagree with.
4. Do you support "Critical Race Theory," why or why not?	Declined to Respond	No, definitely not. I have done extensive research into understanding what it is and how its ideas are hidden with the intention of keeping it from being identified. It is a direct rejection of the values put forth in the Bible as well as the values espoused by the Constitution. It advocates for laws equivalent to those Jim Crow era laws, only with different targets.
5. If faced with a budget deficit, would you support cutting spending or increasing student fees or tuition? What would be your reasons for this decision?	Declined to Respond	Assuming the problem isn't caused by mismanagement, it would probably be a combination of all three. I would first start with cutting spending before I would go onto anything else.
6. How do you view the role as a trustee member in regard to public policy like taxes?	Declined to Respond	It is the primary responsibility of the Trustee to represent the public interest at the College. Taxes should be minimized by making the College as efficient as possible and only supporting programs that the community strongly wants.

7. Do you support the ability for employee unions to automatically deduct money from their members' paychecks to finance political activities, why or why not?	Declined to Respond	No. Political activities are up to each citizen as to whether or not they want to support them.
8. Do you support or oppose bathroom and locker room usage based on preferred gender identification? Why or why not?	Declined to Respond	I support bathroom and locker room usage on biological identity only.
9. In what ways can North Idaho College help local high school students prepare for a college education or for a trade school?	Declined to Respond	NIC already has a dual enrollment program that does an excellent job of helping with this. NIC would likely benefit from having a new program focused on providing summer classes for high school students where the classes are not a part of a larger program but instead intended to help students better find what programs they are interested in.
10. What is your opinion regarding freedom of choice for parents for the education of their children (School choice)?	Declined to Respond	The ability to choose where your children go to school is vitally important. Further, the ability to actually know what is being taught at a school before you send your children there is just as important.
11. How would you, as a trustee, create opportunities for an education more equitable towards students coming from a private or homeschool background?	Declined to Respond	One of the steps I will take is talking to many individuals in our community with a focus on parents of high school students. I hope to find out what their perception of NIC is, what they would want to see changed within it and what would help them send their children to NIC. I expect this will, at least in part, involve having advisors who talk to local homeschool organizations and provide assistance as needed.
12. What does the term "education" mean to you?	Declined to Respond	Teaching skills to students which will benefit them and the community. The goal first is to teach, not to indoctrinate.
13. Do you support or oppose the legalization of marijuana? Why or why not?	Declined to Respond	I do not support the legalization of marijuana except as a controlled medical substance. It is mind altering and can damage users, especially younger users.
14. What is your background and why does it qualify you for this position?	Declined to Respond	I have extensive experience managing larger corporations than NIC, even if you include the students in that number. My experience has also had a significant focus on reorganization and changing the culture of companies, even doing so when teams don't want to change. This experience will be helpful in trying to solve the root cause of NIC's enrollment problems, namely, that NIC is not a safe place for Christians to send their children. While I hope that is only a perception problem, I am concerned that it is in fact a true statement.

1. What is your name, what office are you running for and why are you running for this position?	My name is Joe Alfieri and I am running for Idaho State Legislature, House seat 4A. I'm running because we need true conservative representation in the House that reflects the will of the people.	Declined to Respond
2. When do you believe life begins and how does this belief affect the legislation you will support?	Life begins at conception, and I will support any and all legislation that honors the sanctity of life.	Declined to Respond
3. What are the top three issues that you feel the legislature needs to address?	The first three issues that the legislature must address are taxes, government overreach, and election integrity. We must eliminate the grocery tax, and reduce the overall tax burden. The legislature must ensure that our constitutional rights are protected and prevent mandates. And we must tighten our election laws and forensically audit our elections.	Declined to Respond
4. What do you consider the biggest health care issue for Idaho, and where do you stand on it?	The biggest health care issue is the imposition of mandates and other restrictions on our freedoms, under the guise of a health crisis. It is not within the purview of the government for it to dictate how individuals and organizations address health care issues. We have set a dangerous precedent, and must reverse course immediately. If elected, I will propose legislation that would prevent an increase beyond a modest amount (perhaps 1%) per year, and ony assess true values if the owner sells the house. This is similar to California's proposition 13, which helped homeowners protect their homes.	Declined to Respond
12. In your opinion, should the House of Representatives and the Senate have their own attorney/legal representation apart from the Attorney General?	Absolutely. Currently, the state's Attorney General, as a member of the executive branch, serves the governor. (He should serve the people, but that's another long story.) Declined to Respond	A Libertarian viewpoint would be that the government has no business telling me what I can or cannot consume. In addition, they would claim that using marijuana is a victimless crime. I believe there would be a large number of users who would be responsible enough such that no one would even be aware that they were using the substance. However, there are a number of reasons that tip my decision away from legalization. Foremost is the cavalier attitude that this action will have on youth, that society now appears to approve of getting high. It will increase usage among teens, and marijuana affects young brains that have not fully developed until around age 25. Safety behind the wheel and in dangerous occupations is also a concern. The tax revenue derived from marijuana would not cover the social costs of enforcement and drug treatment. The criminal black market would prosper since there would be more demand, and these "entrepreneurs" can always undercut the price of a state-controlled substance. Organized crime would also increase the presence of other illegal activities such as illegal drugs and sex trafficking. I believe that there are legitimate uses for marijuana and would be in favor of legalizing medical marijuana.
