What is your name, what office are you running for and why are you running for this position?</p>	<p>Joined the Race after the questionnaires were sent out for the May Primary.</p>	<p>My name is Steve Fioravanti. I'm running for Boundary County Commissioner, District 2. I'm running because I would like to see more transparency and citizens participation in our county government. Our current Board of Commissioners lacks foresight and vision and we need an infusion of creative ideas and energy to tackle the complex issues that face us today. I will defend our God-given rights of life, liberty and property. I stand for medical freedom and I oppose all unconstitutional mask/vaccine mandates.</p>

Under what circumstances do you believe it should be used?</p>		<p>The exercise of governmental power of eminent domain to acquire privately owned land should only be used in an extreme situation. I would support taking the necessary action to secure our border in a situation like this.</p>

Our county is growing very rapidly, where do you see we need to improve infrastructure and what are your plans to improve it?</p>		<p>We currently have gridlock to access building permits in our county. Boundary County used to have its own planning and zoning department staffed by a county employee. We now subcontract this function to a private firm based in Sandpoint. I've heard numerous stories from exasperated citizens as they've fought to get timely and consistent answers from this private firm. It has caused unnecessary construction delays and has led to gridlock. This needs to change.</p>
<p>6. Due to the rapid growth in our communities, our schools are reaching maximum capacity. What are your plans to accommodate more schools to meet the growing needs of the increased population?</p>		<p>Competition to public education is good and we should look to alternative means of educating our children. I fully support candidate Branden Durst, who is running for Idaho Superintendent of Public Education. His platform calls for a parents right to choose. Money will follow students to any school: traditional, charter, private, micro school or something else.</p> <p>School choice is an excellent option for parents when the funding follows the student. This gives parents more choices to choose from in their children's education. These alternative options would ease the burden in our crowded schools and eliminate the need for more bonds and tax levies on our citizens.</p>
<p>7. Do you support or oppose Urban Renewal Districts? Why or why not?</p>		<p>I would support an urban renewal project with the caveat that no individual's property was seized improperly. In addition, it would have to be a privately funded project without the use of tax payer money. The project should be vetted with community engagement to garner support, and it should follow planning and zoning requirements.</p>
