<b>3.</b> What are your views on the rapid growth of North Idaho?		We cannot avoid growth. But we can determine what is the nature of growth, and how to preserve Hayden's small- town character. Home ownership is the bedrock of a stable community. It encourages volunteerism in one's community. Apartments do not. I have seen for myself how rezoning communities to encourage cheek-to-jowl apartments and townhomes have reshaped these communities into lawless nightmares. I spoke with Sheriff Norris, and we both agree that single family home ownership is far better for the community. Do we want to look like Portland, Seattle, or even Spokane in another generation? I don't. I am passionate about keeping our small town character and working to keep it that way for generations to come.

<b>5.</b> What improvements should be made to the city councils' role in the design and authorization of new developments?		The city council should have a much larger voice than it currently does. Right now, the city staff is in control and that needs to change. City staff should be following the direction of the city council, not the other way around. As elected officials, city council members are accountable to the people. They need to be hearing from and prioritizing the voice of the people in all their decisions. This includes the design and authorization of new developments. Builders should not have "by right" development decision making authority, which effectively silences both the voices of city council and the people.	
6. In your opinion, should any services currently provided by the city be cut, eliminated, or privatized?	S	Hayden's public works budget seems out of proportion for the city's population. This section of the budget needs closer scrutiny.	
7. Do you believe access to city managed water and sewer should be increased to rural communities and why?		No. Build-out of city sewer and water infrastructure is a means to justify greater growth. For rural areas of the city, if zoning is kept to agriculture, there isn't a reason to build-out sewer, since septic fields are spread out far enough.

<b>8.</b> How do you plan on keeping a healthy reserve fund without increase taxes?		Once in office, I plan to make a line-item budget analysis to determine areas that can be altered for the betterment of our taxpayers, including a reserve fund.
<b>9.</b> What is your opinion of the increased push for affordable housing?		The lack of affordable housing is a problem created by our federal government and Federal Reserve. It's a nation- wide problem. It is a fallacious argument to say that we can locally make housing more affordable without also losing the small-town feel, and quality of life here in Hayden. We will have to vastly increasing apartments and low- quality townhomes, and accept government subsidized housing, all of which quickly become decrepit, and do nothing to keep residents invested in our community.
<b>10.</b> All too often local residents feel that their public comment is not taken into consideration when decisions are made that directly affect their daily lives and their property value. What would you suggest so that the public's best interests become a priority over builders and developers?		Specifically, for the Hayden City Council meetings, I will argue for getting rid of the consent calendar, asking that informational packages be published at least two weeks before city council meetings (as opposed to the four days they have now), and allow public comment on subjects being voted on in council meetings. Every topic should be fair game, and it is our First Amendment right and our responsibility to keep our elected officials accountable. I know first-hand what it feels like to stand before city council addressing them with my concerns, like the destruction of the wetland in my area, and have those concerns fall on deaf ears. This is not acceptable. We The People is exactly what it says. We the People are the government and elected officials work for us. That is my mindset and how I will function in office.
<b>11.</b> What is your opinion of "Smart Cities" and how they apply to North Idaho?		I'm against them in all shape, manner and size. The things happening now to rezone Hayden and surrounding communities to fast-track high-density neighborhoods, build-out of sewer and water infrastructure into rural areas, are all laying the ground work for future smart/15-minute cities. Taking federal subsidies to encourage these things and balance budgets always come with strings attached, and smart cities is high on their priority list, whether they admit it or not. North Idaho is one of the very few last bastions of freedom, liberty and impendence from government. I intend to fight to keep it that way.
<b>12.</b> Should the concept of "equitable outcome" be implemented as a part of the city council's decision-making process? Why or why not?		Equitable outcome is a Marxist ideology. To guarantee a specific outcome for one group of people requires taking from another group of people. I oppose it.
