What would you suggest so that the public's best interests become a priority over builders and developers?						It is imperative that all government provides adequate opportunities for public input whether in the form of public hearings, townhall meetings, and open door policy for one-on-one discussions as long as we work within the guidelines of the public meeting laws. In Spirit Lake, we have properties within the city limits owned by individuals who currently cannot build due to the DEQ Moratorium. Individual landowners within our city limits should have priority to purchase building permits over builders and developers.
11. What is your opinion of "Smart Cities" and how they apply to North Idaho?						I believe there is a place in all business to utilize technology for creating efficiencies in services and for cost savings. As a government agency Spirit Lake should look at all options for improving services and saving tax dollars for the community. During a recent tour of the Spirit Lake water and sewer infrastructure, I learned how they are using technology for staff efficiency. Outside of regular business hours, the Public Works staff can troubleshoot system issues from their homes. In addition, there are times when they need to start portions of the sprinkling systems in the evening hours, which can be done using this same technology. It eliminates unnecessary trips to the treatment plant after hours, reducing employee overtime, reducing wear and tear on city vehicles, and reducing employee safety risks.
12. Should the concept of "equitable outcome" be implemented as a part of the city council's decision- making process? Why or why not?						Everyone should be treated equally and have access to local government and its processes in one form or other. In a small community such as Spirit Lake, there are many who may not have access to technological options for keeping up with the government processes, notices of meetings, agendas, etc. It's important to ensure everyone has access to the same information.
