What is your name, what office are you running for and why are you running for this position?	<b>No Response Received</b>	<p>Brian Domke Bonner County Commissioner District 1 I am running for this office because of the desire to bring decorum, professionalism, and effectiveness back to the Bonner County Board of Commissioners. The current dysfunction within the board of county commissioners has created an environment that is functionally inefficient, creating unnecessary liability, creating a work environment that negatively impacts the retention and recruitment of county staff, and has resulted in a relationship between the board of county commissioners and the public that is adversarial. 4. Do you support or oppose forced annexation? Why or why not?	No Response Received	I am opposed to forced annexation. I believe that changing the municipal designation of a privately owned parcel from the county to a city should be at the agreement of the private property owner. If city owned utility services or other infrastructure serve a property that is not currently within a city's limits, the provision of such services and/or infrastructure should be based on mutual agreement made between the city municipality and the private property owner.	I do not support forced annexation. An established community, unincorporated or incorporated, has established itself and should not be forced into adopting the ordinances of a neighboring community. 5. Our county is growing very rapidly, where do you see we need to improve infrastructure and do you have plans to improve it?	No Response Received	I believe that the county's system of roads and bridges is our most critical county-maintained infrastructure. To prioritize where our road and bridge infrastructure needs to be given the most attention for repair and/or improvement, I believe we should follow the four-step process of assessment, prioritization, budgeting, and then implementation. First, we need to understand which roads/bridges are experiencing the highest volume of traffic, while also confirming the existing condition of each county road/bridge. Second, the roads/bridges with the highest traffic that also are in less than good condition should be given a high priority for maintenance and/or improvement. Third, the appropriate budget amount should be applied to the higher priority roads/bridges. Last, the road/bridge maintenance and/or improvement should be implemented by following the budgeted priority items. Also, the county should continue to pursue obtaining grant funding (preferably from the state) to reduce the financial burden to the county taxpayers for this critical infrastructure.	There are several areas of our infrastructure that need improvement. Prioritizing these needs based on safety concerns, environmental concerns, and foresight of future growth is an area that extensive business experience is necessary for proper planning. No Response Received	I am opposed to Urban Renewal Districts since they create an unbalanced tax rate between those property owners within the district compared to those property owners who are not within the district. The formation of Urban Renewal Districts also includes the establishment of an Urban Renewal Agency and possibly a governing board. Such new agencies and governing boards can be established through appointment, instead of being positions held by those who are elected. The creation of appointed agencies or boards results in moving power and control of our local government further from the citizens of our county, which in turn reduces accountability. Potentially yes, if proper experience is not elected to the Board of County Commissioners. Having worked with BOCC's for several years while working for Idaho Forest Group, I have seen the benefits of business experience in our county leaders. Having this experienced leadership managing the departments and budgets of the county can lead to substantial cost savings while maintaining a balanced budget. For example, reducing employee turnover can lead to a savings of >35%/replaced position.	<b>Running Unopposed</b>
<b>11.</b> In recent years some groups have advocated for legalizing marijuana in our state, do you support or oppose the legalization of marijuana? Why or why not?	<b>No Response Received</b>	It should be noted that the legalization of marijuana or any other controlled substance is a state statute level issue, not a county code/ordinance level issue. With that clarification in mind, the enforcement of state laws concerning controlled substances does become a county issue when local law enforcement, the county prosecutor, and the county jail become involved in addressing violations of such state laws. While I support the thoughtful use of medical marijuana, for medicinal purposes in the treatment of medical conditions under the guidance of a medical professional, I do not support the legalization of marijuana as a recreational drug. We need only look at other nearby states where the recreational use of marijuana has been legalized to see the harm that would result to our county community. <b>12.</b> What should the county's policy be regarding federal funding of county projects?	<b>No Response Received</b>	My desire is to eliminate the county's reliance on federal funding. Unfortunately, this is a process that will take a long time to accomplish due to the decades of state and county decisions that have resulted in a significant county dependence on federal funding to supplement many areas of the county budget. To begin the process of breaking the chains created by federal funding, I believe that the county should seek to reduce its reliance on federal funding for county projects to the greatest extent possible. When considering the use of federal funding for county projects, each case should be evaluated to determine what federal requirements are	Bonner County currently relies on funds from the Federal Government, regardless of if these are directly funded to Bonner County or routed through Idaho State. <b>13.</b> What is your opinion on restricting public comment at county meetings? Why do you hold this opinion?	<b>No Response Received</b>	I believe that the board of county commissioners should welcome public comment during the agenda items of the county business meetings to gain knowledge and awareness prior to final deliberation and voting by the board. While including public comment will likely result in the business meetings taking a little longer, making better informed decisions will lead to better outcomes that will be more cost effective in the end. While welcoming public comment prior to making board decisions is a good business practice from a fiscal responsibility perspective, it is even more important from the perspective of upholding the constitutionally protected rights of the citizens of our county. Both the United States Constitution (Amendment I) and the Idaho State Constitution (Article 1, Section 10) guarantee the right of the public to peaceably assembly, and in doing so, to instruct and/or state their grievances to their elected representatives. Any attempt to restrict these constitutionally protected rights is a form of tyranny. I also believe that the board of county commissioners should encourage respectful dialog and decorum from the public by modeling such behavior themselves.
