If there is a death shown from the use of Fentanyl dealers actions then prosecute for that death.	House Bill 406 will help local communities combat fentanyl trafficking by setting mandatory prison terms beginning in July 2024, Also, the same law includes prosecution for delivery of narcotics in which a death results. Idaho was one of the last states to enact a law which allows local prosecuting attorneys to charge a drug dealer with the death of drug user. Idaho needs to continue to have aggressive drug laws, enforcement, prosecution, and sentencing to protect our county from the devastation drugs have caused in many of our neighboring states.
