Encouraging constituents to work at polling positions at each precinct. Encourage local political committees to submit their list of election judges as per Idaho Code 24-303. If elected I will learn more about how and what our county has in place and what their procedures are. I really cannot advise at this point as I am not sure.	In Shoshone county, actively soliciting for volunteers as poll watchers and vote counters is an area where we struggle. If private property owners desire to work together to bring about change in their neighborhoods, this should be encouraged, but definitely not mandated by governmental authorities, nor should private property be taken by them. As clerk, I would have no direct authority to create or terminate these districts, only to manage the funds entrusted to the county by the taxpayers.
6. What is your preference on paper ballots vs. electronic ballots?	No Response Received	According to brennancenter.org they released a report on August 15th 2019 that the estimated cost for cyberattack on elections was \$833 million. I believe that if there is cyber, we will have attacks. It cannot ever be totally secure. Cyber attacker's only goal is to steal, kill and destroy. That is a lot of tax dollars being spent on an issue that could be resolved by simply going back to paper ballots verses machine. Paper ballots and hand counting worked for hundreds of years.	Paper ballots present less security challenges, and in a small county, such as Shoshone, it is still possible to count by hand. I would endorse paper ballots and recommend their use, as well as counting by hand to ensure the security and accuracy of our elections.
7. In your opinion, what does the Clerk provide in terms of checks and balances regarding the other elected officials?	No Response Received	A county clerk is responsible for numerous duties. One of the main duties is to ensuring that all account services and financial reporting is current and accurate. The Board of County Commissioners would not be able to move forward in their daily duties without knowing the available funds in accounts and if contracts and procurements are nondelinquent. This position helps to ensure there is no over expenditure of tax payer dollars.	The clerk has the job of making sure that the monies that are budgeted are being spent in accordance with that budget. They must regularly be working with the commissioners who set the budget so as to inform them of potential issues with the budget, and they must be working with the different departments in the county to ensure that the budget is being followed. It is through this management that the clerk is able to provide that balance for the other elected officials.
