5. Idaho's school system has room for improvement, how would you legislate to improve K-12 education in Idaho?	The Blaine amendment was wounded as a result of the Espinoza v. Montana decision several years ago. It opened the door to funding of private schools. The recent Launch program legislation, a gov't directed vocational training which funds education beyond grade 12, further supports private school funding under the above court decision. Though the Idaho Constitution clearly prohibits the funding of sectarian education, school day curriculum which avoids religion, until after the formal school hours may have some promise. I would support and propose a \$6K dollar voucher that follows the student, K-12, to private and home schools, and/or an \$8K tax exemption in the amount of the current ADA funding amount, \$11K-\$12K. Families having to pay for 2 education programs, one of which they are not using, public education, is and unfair public policy. A slight constitutional amendment which includes "public and private free common schools" is needed for ability to fund private schools.	No Response Received
6. Do you support or oppose legislation to prohibit gender reassignment treatment/surgery on minors? 11. What legislation would you recommend to prevent property tax increases that are causing a financial burden and forcing some owners out of their homes?	I would seek state reimbursement to the counties in the amount of \$5K to purchase a Costar, national commercial revenue assessment tool that would shift an unfair disparity between residential and commercial assessments. I would like to see the taxpayer who is cash poor property rich seek a reverse mortgage payment of taxes through an Idaho state bank, similar to that of the Bank of North Dakota. A bank that promotes fairness and does not exist to exploit the consumer. While home owner exemption (HOE) increases provide some immediate residential relief, the HOE's do shift the tax burden relief onto other ownership classifications such as a nonresidential, rental, homes and lot lands. The increase to these other classification can lead to more minor land divisions and infrastructure growth. Any HOE changes required in the interim of a better "fix" should be attached to a combination of national, state and local sales market valuations and the shadowstats inflation analysis.
