3. What are the top three issues that you feel the legislature needs to address?	I believe the top three issues that should be addressed for the 2025 legislative session are school choice, inflation/property taxes/state economy and the impact of illegal immigration and the open border. Regarding the illegal immigration and the border issues, in 2024 I authored House Bill 615 (withholds public benefits from illegal aliens) and House Bill 464 (state compact for border security similar the the Texas bill). I will being both bills back in 2025. I will also bring one or two bills that address a constitutional money system, which can reduce inflationary pressures. Lastly, 2025 will be the year we approve a school choice bill. There will likely be several school choice bills. During each of my 10 years in the Legislature, I have authored several bills, and have gotten many of them signed into law. I believe I am one of only a few legislators in the last 20 years who got a bill signed into law that limited the authority of the federal government in Idaho, and I have done this twice.
